The board has been very busy during this first year of the biennium, planning contribution campaigns and fundraising events, attending RAW meetings, and processing applications for Aspiring Educator Grants and Project Stipends.

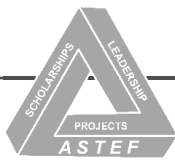
TSO members are consistently taking advantage of opportunities to contribute on a regular basis, as well as applying for and receiving the benefits of the leadership opportunities, scholarships, grants, and stipends provided through ASTEF.

Highlights of 2023-2024 include:

- Added official representatives to each Regional Area Workshops (RAW) planning committee
- Changed the name of the ASTEF Finance Committee to ASTEF Financial Affairs and Governance Committee
- Changed the Advocate for Education Award to bi-yearly (contingent on RAW continuing after 2024)
- Updated all application forms and posted on the ASTEF Website
- Posted the rubrics for Aspiring Educator Grants and Project Stipends on the ASTEF Website for transparency
- Updated the website, displaying current information as well as meters during each contribution campaign
- Created a breakout session presentation to be used at all the RAW events
- Conducted fall and winter contribution campaigns with unaudited totals of
- \$16,806.85
- Awarded 7 Aspiring Educator Grants totaling \$7,000
- Awarding \$26,513.10 in Project Stipends to 20 chapters or individuals at this year's RAW events
- Launched the PAD Pals (Past ASTEF Director Pals) program to connect present ASTEF directors to former directors, soliciting input, assistance, and keeping them informed
- Managed TSO Scholarship funds to award \$14,750 for 2024-25 per the TSO Scholarship Committee
- Accepted responsibility of managing the UT Scholarships (3) on recommendation from the TSO Executive Committee
- An Ad Hoc Committee began reviewing and updating the ASTEF Guidebook
- An Ad Hoc Committee was formed in early 2023 for RAW considerations; the committee is continuing its work through writing ASTEF's History and exploring the need for ASTEF Presidents' Pins
- The ASTEF Weekender is being planned for October of 2024 in Waco
- Organized a fundraising event for the RAW as the TSO Unifying Project

Delta Kappa Gamma Society Founders

The Society was founded May 11, 1929, at the University of Texas Faculty Women's Club, Austin. Dr. Annie Webb Blanton, faculty member at the University of Texas and first woman elected to a Texas statewide office, conceived the idea of an honor organization for women educators and selected eleven from Texas to help her create "The Delta Kappa Gamma Society". Two honorary founders were named by the 1949 State Convention since Texas was the only state without State Founders other than the original twelve shared with the whole organization. Biographical information may be found in *Our Heritage Volumes I, II and III*. Texas chapters are encouraged to remember and honor the vision of these women.
