#### 07/06/2023 UPDATE

If the treasurer is having login trouble, they need to use a two (multi) factor authentication (MFA) system. Most created a MFA account using ID.me last year.

However, some of the early filers last year were able to use their old login. If the filer did not create an MFA last year they will need to **set up an MFA to login**.

The IRS now has two options LOGIN.GOV or ID.me. **Treasurers should select ID.me and have a cell phone to receive a** <u>text message or a phone to receive a phone call with an authentication</u> <u>code each time they log in.</u> The phone #s are selected during the ID.me login set up.
